to me at that time he was looking for a fight with George. George then tried to go past Graham, taking a hold of the front of Graham's shirt to try and move him out of the way. This was obviously a catalyst for Graham to erupt and attack George. Graham then placed George in a headlock, dragging him outside and into a parked van outside opposite the address. Graham then proceeded to kick George's legs from underneath him, causing George to fall to the pavement very heavily onto his left side. I winced when I saw George fall and really feared for his safety. Graham at this time was like a madman and had completely lost it. Once George had fallen, Graham immediately jumped onto him and grabbed a hold of George's head with both hands. He then started banging George's head onto the pavement a number of times. It was making me feel physically sick at this time and I was shouting out 'LEAVE HIM ALONE. HE IS SERIOUSLY ILL'

Graham ignored me and continued banging George's head into the pavement. He then started to punch George a number of times, as well as grab a hold of George's jaw area. It was only when George screamed out in agony, after Graham had stuck his knuckle into George's left eye, that Graham stopped hitting him. All of this time, I had been trying to pull Graham off George. It was a very frightening experience. It really disgusted me in that Graham could act in that way to another defenceless, ill human being. Once Graham had stopped attacking George, he moved away from him for a second or so and then launched back into George kicking him a number of times to the body again. He then stopped the attack, as a number of people had gathered by this time. Graham then started shouting obscenities at me calling me a 'FUCKING WHORE' and a 'FUCKING BITCH' a number of times.

George eventually managed to get to his feet and was approached by a number of people who were concerned about his state of health. At that time I could see that George's left eye was partially closed and was badly swollen. I then asked my neighbour to call the Police, whereupon Graham shouted 'THEY'LL NEVER BELIEVE. HE ATTACKED ME FIRST.'

Me and George then got into his vehicle and drove away to the Gro car park, Llanidloes, to cool the situation down. We sat there a while before going to George's house to recover.

I have been informed of the Victim Personal Statement scheme and have been given the relevant leaflet in relation to this scheme. In relation to this, I would like to add that since both incidents involving Graham McArthur, I am very unsettled at the fact it has all happened. I am scared he will come back and start making trouble again. I live at home with my 15yr old daughter and am in constant fear of him returning. Both my daughter and I have had sleepless nights since the incidents and I am seriously
